Reports

The Secretary's Report was distributed. Judy Herrala asked if there were any changes or corrections. There were no changes or corrections. *Lisa Rixe made the motion to accept the minutes as presented. Delores Yoraway seconded the motion. No discussion. Secretary's Report was approved.*

Old Business

- Liability Insurance: State Farm felt it was not necessary for us to take additional liability insurance. Our premium went up to \$650 this year from \$575 last year.
- Headstone damage: Agreed in 8/21/22 trustee telephone meeting to cover half of replacement cost of stone (value up to \$1499). Tanya and headstone owner did not agree on cause of damage. Cemetery stance (after conferring with Braham Monument) is that stone was faulty because there are no signs of physical trauma. Owner stance is that stone was mishandled. Supplier of stone was on-line purchase and has gone out of business. *Tanya left message with owner will get in contact with them.*
- Cemetery rules now specifically state headstones are not responsibility of the cemetery.
- Dying trees: please see Annual Meeting Notes. *Tanya will get bids and decision will be made by Trustees via telephone meeting*.
- Huntington in Coon Rapids is currently providing complimentary notary service to Cedar Cemetery.

New Business

- Tax discussion: Tanya Guy confirmed we have no need to file per rules regarding older non-profit cemeteries.
- City Run Cemetery: Marie McCallum of West Oak Grove Cemetery is exploring the idea of following a process taken by Eden Prairie to turn its cemetery over to the city for management. Evidently, it is a 5-year process done with the help of a law firm in Minnetonka that specializes in cemetery legal issues.
